- 3. Medical Treatment. I hereby release and forever discharge Pro Bono Legal Services, Inc. from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time with Pro Bono Legal Services, Inc..
- 4. Assumption of the Risk. I understand that my time with Pro Bono Legal Services, Inc. may include activities that may be hazardous to me. I hereby expressly and specifically assume the risk of injury or harm in these activities and release Pro Bono Legal Services, Inc. from all liability for injury, illness, death, or property damage resulting from the activities of my time with Pro Bono Legal Services, Inc..

I grant and convey unto Pro Bono Legal Services, Inc. all right, title, and interest in any and all photographic images and video or audio recordings made by Pro Bono Legal Services, Inc. during my work for Art on the Beach, including, but not limited to, any royalties, proceeds, or other benefits

derived from such photographs or recordings.

6. Other. I expressly agree that this Waiver is intended to be as broad and inclusive as permitted by the laws of the State of South Carolina in the United States of America, and that this Waiver shall be governed by and interpreted in accordance with the laws of the State of South Carolina. I agree that in the event that any clause or provision of this Waiver shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
